This is regarding Compliance Report submitted by **Lendi Institute of Engineering and Technology, Vizag- Vizianagaram Road- NH- 43, Denkada Mandal, Jonnada, Andhra Pradesh-535005** for the UG Engineering programs were accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30/06/2021. The programs whose accreditation had expired on 30/06/2021 were granted one-year accreditation for AY-2021-22 up to 30/06/2022 due to the present pandemic situation.

2. An Expert Team conducted data verification of the programs on **22nd May, 2022**. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The programs have been granted accreditation for further 3 years. **Lendi Institute of Engineering and Technology, Vizag- Vizianagaram Road- NH- 43, Denkada Mandal, Jonnada, Andhra Pradesh-535005** should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Lendi Institute of Engineering and Technology, Vizag- Vizianagaram Road- NH- 43, Denkada Mandal, Jonnada, Andhra Pradesh-535005** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
